As long as NONE of the following statements apply...

eligibility question #1, or are a drug abuser or addict You have ever engaged in terrorism, espionage, sabotage

• You have a **serious communicable disease** as per ESTA

- or genocide (or plan to) You have ever fraudulently obtained - or attempted to
- obtain a visa or entry into the USA You are seeking employment in the USA, or have been employed there without permission in the past
- You have previously been denied a U.S. visa that you applied for with your current or previous passport, or been **refused admission** to the USA, or withdrawn your application for admission at a port of entry You have stayed in the USA longer than the admission period granted
- You have a physical or mental disorder with a history of associated
- **behaviour that may pose a threat** to property, your safety or the welfare of others • You have previously had a physical or mental disorder as per the
- previous point which is likely to recur or lead to other behaviour potentially harmful to property, your safety or the welfare of others ...you're eligible to apply to travel under the Visa Waiver Program (aka
